THE MINISTER OF STATE IN THE MINISTRY OF LABOUR AND EMPLOYMENT (SHRI KODIKUNNIL SURESH) : (a) Some security agencies including British Company M/s. G4S Secure Solution (India) Pvt. Ltd. have defaulted in depositing contribution with Employees' Provident Fund Organisation.

(b) Company-wise details of defaulting security agencies is not maintained centrally in the Employees' Provident Fund Organisation.

(c) and (d) Notices have been served on all defaulting security agencies to deposit their contribution with the Employees' Provident Fund Organisation.

(e) As on date, an amount of Rs 19.14 crore has been recovered from such defaulting companies and Rs 220.56 crore is outstanding against these companies.

The policy has targeted skill development of 500 million persons by 2022 by involving all stake holders through concerned Ministries and Departments.
