Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of funds allocated State-wise under Swachh Bharat Mission-Urban (SBM-U) scheme during the last three years;
- (b) the details of funds released, State-wise including the State of Andhra Pradesh under the said scheme during the last three years;
- (c) the details of funds spent/unspent, State-wise under the above scheme; and
- (d) whether Government has achieved the desired objectives of the scheme?

(a) to (c): Under Swachh Bharat Mission-Urban (SBM-U), a sum of Rs. 14013.46 crores has been allocated to all States/Union Territories (UTs) for the mission period i.e. 2<sup>nd</sup> Oct, 2014 to 31<sup>st</sup> March, 2020, out of which Rs. 9704.35 Crores has been released till date. State/UT-wise details of fund allocation, releases, balance and utilisation certificates received, including the State of Andhra Pradesh is at Annexure.

(d): The major objectives of SBM-U are: (i) to make all the urban areas in the country Open Defecation Free (ODF); (ii) 100% scientific processing of Municipal Solid Waste (MSW). Till date, all the urban areas of the country excluding 52 ULBs of West Bengal have been declared Open Defecation Free (ODF) and 58% of municipal solid waste is being processed scientifically, a threefold increase as compared to 19% in 2014.
