FUNDS ALLOCATED TO ANDHRA PRADESH UNDER AYUSHMAN BHARAT YOJANA

3755. SHRI Y. S. CHOWDARY:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the details of the Heads and the amount of funds allocated under them in Andhra Pradesh and Telangana by Union Government under the Ayushman Bharat Yojana during the last three years;
- (b) the number of patients benefitted under the Ayushman Bharat Yojana in those States and the amount of funds allocated by Union Government for the same and the amount of funds targetted to be allocated from State's Head; and
- (c) the details of the number of families registered so far under the said scheme and the number of families remaining to be registered, district-wise?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) to (c): Central share of funds is released to States/UTs as Grants-in-Aid for implementation of Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) as well as for incurring administrative expenses, as per the funding pattern prescribed by Ministry of Finance. An amount of Rs. 859.24 crore is released to the State of Andhra Pradesh during last three years towards Central share. The State of Telangana joined the scheme in May, 2021. An amount of Rs. 150.26 crore is released to the State of Telangana during 2021-22 towards Central share. As of 31st March 2022, a total of 24.65 lakh and 3.22 lakh hospital admissions are authorized under the integrated scheme(s) in Andhra Pradesh and Telangana respectively. District-wise details of beneficiary families covered in the State of Andhra Pradesh and Telangana are at Annexure-I and Annexure-II respectively.

- 1. Hanumakonda district was listed in SECC 2011 by its erstwhile name Warangal Urban district
- 2. Narayanpet district was formed in 2019 after bifurcation of Mahbubnagar district, therefore SECC 2011 beneficiary family data in Naranyanpet was enumerated under Mahbubnagar district
- 3. Warangal rural was named as Warangal district in 2021. SECC 2011 beneficiary family data for Warangal district was enumerated under its erstwhile name i.e., Warangal Rural district
- 4. Mulugu district was formed from Jayashankar Bhupalpalli district in 2019; SECC 2011 beneficiary family data for Mulugu is therefore under Jayashankar Bhupalpalli district
- 5. Several districts were formed after the creation of Telangana State due to which SECC 2011 beneficiary data of these districts would be enumerated under their erstwhile names. As a result of this, SECC 2011 data of 53,417 beneficiary families could not be assigned to any district. This would however be subsumed within the total beneficiary family base of the State.
- 6.All eligible beneficiary families in Telangana can avail healthcare services under the integrated scheme by providing their ration card. Hence, Ayushman cards are not created for the scheme beneficiaries in the State.
- 7. Additional beneficiary families are covered by the State at their own expense.
